

## Agency Services

- **24-Hour Crisis Line** — The crisis line is staffed 24 hours a day, 365 days a year by a certified crisis counselor. Last year, counselors responded to 1,987 callers.
- **Housing** — Emergency shelter for women and children is available for up to 60 days. Transitional housing for up to two years. Last year, safe housing was provided for 68 women and 72 children.
- **Counseling, Advocacy & Support Groups** — Individual counseling, court advocacy, child advocacy and support groups for 2,582 victims and survivors. These services increase the opportunity for healing and a life without violence.
- **Community Education** — Educational programs are designed for students in grades K-12, civic and church groups and professional in-services. These presentations build an understanding of the scope of abuse and its impact on individuals and the community. Last year, 8,669 students and other individuals participated in community education programs.
- **Special Projects** — DCF & SBAP Partnership, Susan B. Anthony Project staff serve as domestic violence consultants with the Department of Children and Families' child protection case worker.
